

Consent

personal data processing

If you indicate your consent to the provision and processing of personal data, you acknowledge that, within the reading and extent of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter referred to as the "GDPR Regulation"), you have been given information by the data processing Controller about personal data processing and that you have been instructed on the rights and obligations of the data subject; and you **agree** with processing of your personal data: **gender, name, surname, telephone number, email address, city/town, born year** (hereinafter referred to as "personal data") by the Controller:

Slovak National Theatre [Slovenské národné divadlo] with seat at Pribinova 17, 819 01 Bratislava, Company Registration N°: 00164763 (hereinafter referred to as "Controller"), for the purposes of: **marketing activities (sending direct mails, newsletters, placing valid advertising on social networks Facebook, Instagram, portal YouTube and in the Google search engine), specifically information on competition, premières, performances, events convened by the Slovak National Theatre, and special offers.**

The consent applies to all data processing activities involving personal data for the same purpose.

The data subject gives their consent to personal data processing for the period of 5 years from the date of awarding the consent. After the expiration of the above period, the Controller shall, without delay, eliminate (delete) from the information systems of the Controller all personal data provided. This doesn't apply in the event the data subject exercised their right to deletion in line with Article 17 of the GDPR Regulation.

The consent may be revoked anytime in writing to the address of the Controller or by sending email to odhlasenie@snd.sk.

The data subject is entitled, under the terms set out in the GDPR Regulation, to request from the Controller access to the personal data related to the data subject, and shall also be entitled to their correction or deletion or limitation of processing, or to objecting their processing, as well as to transfer the data. The rights of the data subject are further set out in Articles 15 – 23 of the GDPR Regulation and on the website of the Controller: www.snd.sk.

The Controller has designated staff member for personal data protection. The data subject may contact the designated staff member in connection with any issues concerning their personal data processing and exercise of their rights pursuant the GDPR Regulation; contact details for the designated staff member are e-mail: zodpovednaosobagdpr@snd.sk or in writing to the address of the Controller by identifying the letter "GDPR Designated Staff".

The Controller does not publish personal data of the data subject and does not exercise their transfer to third countries.

In the even the data subject believes that their personal data processing is in breach with the GDPR Regulation, he or she may file a complaint at the Office for the Protection of Personal Data of the Slovak Republic, Hraničná 12, 820 07 Bratislava 27, Slovakia, phone: +421 /2/ 3231 3214, e-mail: statny.dozor@pdp.gov.sk or with any other supervisory authority pursuant Article 77 of the GDPR Regulation.

The data subject acknowledges that he or she has provided their personal data willingly, without pressure, the data are true and he or she agrees with their use within the purpose identified.

Your rights arising from the Regulation and Law

Right to access

You are entitled to receive a copy of personal data which we have on you, and of information about how we use your personal data.

In most cases you will receive your personal data in form of written document, unless you require other means of presentation. If you requested the information electronically, you will receive it electronically, provided it is technical possible.

Right to correction

We adopt appropriate measures to assure the information we have on you is accurate, complete and current. Should you believe that the data we have are inaccurate, incomplete or out-of-date, do not hesitate to ask us to correct, update or amend the information.

Right to deletion

You are entitled to request us to delete your personal data, for instance in the event when the personal data which we acquired from you are no longer needed to meet the original purpose of their processing. Your right, however, has to be examined in light of all relevant circumstances. For example, we may have certain legal and regulatory commitments, what might mean that we would be unable to satisfy your request.

Right to limited processing

Under certain circumstances you are entitled to request us to cease using some of your data. This concerns, for example, circumstances when you believe that your personal data we have may be inaccurate or you believe that we no longer need to use them.

Right to non-transferability of data

Under certain circumstances you are entitled to request us to transfer personal data which you have previously provided us, to a third party of your choice. The right to transfer, however, only concerns personal data we have acquired from you based on consent or contract in which you are party.

Right to object

You are entitled to object processing data that is based on our legitimate interests. In the event that we do not have convincing legitimate reason to process the data and you file objection, we shall no longer process your data.

Rights related to automated decision-making

You are entitled to refuse automated decision-making, including profiling, which might result in a legal or similar significant consequence for you. Please check with relevant section, according to the purpose of processing, whether your data are being processed through such processing operations.

Right to file a complaint

Should you wish to file a complaint against the means by which your personal data is processed, including the exercise of the aforementioned rights, you may approach our Designated Staff Member. We shall duly review all your appeals and complaints.
