### 1 The Scope of the Contract

- 1.1 The purpose of this Contract is the donation of a financial contribution (hereinafter referred to as the "Donation") by the Donors to support and develop the artistic and other activities and traditions of the Slovak National Theatre as the primary theatre scene in Slovakia. The activities of the Beneficiary are defined in the Statute of the Slovak National Theatre No. MK - 2245/2014-110/12966 of July 23, 2014.
- 1.2 This Contract is concluded between the Beneficiary and the Donor in compliance with the provisions of the Statute of the Friends and Patrons of the Slovak National Theatre.
- 1.3 The Donor donates a financial contribution to the Beneficiary in the amount of ..... EUR (in words: ..... EUR) by online payment through the Beneficiary's website, [www.snd.sk/mecenasskyklub](http://www.snd.sk/mecenasskyklub), or, upon agreement of the Parties, by transfer to the Beneficiary's account specified in the header of this Contract.
- 1.4 The Beneficiary gratefully accepts this donation.
- 1.5 The Beneficiary undertakes to use the Donation in compliance with the purpose as set out in Clause 1.1 of this Contract.
- 1.6 The Beneficiary accepts this Donation, which becomes the property of the State in trust for the Beneficiary.

## 2 Final Provisions

- 2.1 Legal matters not regulated by this Contract shall be governed by the provisions of the Civil Code, Copyright Act or other generally binding legal regulations in force in the Slovak Republic.
- 2.2 Any changes and amendments to this Contract shall be made as mutually agreed in the form of written, numbered, and signed amendments.
- 2.3 All differences arising out of or in connection with this Contract shall be settled by the Parties in advance by mutual agreement. Disputes arising out of or in connection with this Contract shall be subject to the jurisdiction of the general court of the place where the SND has its registered office.
- 2.4 The Parties declare that the Contract has been concluded according to their valid and free will, certainly, seriously and comprehensibly, not under pressure and not under clearly disadvantageous conditions. The Parties declare that their capacity and freedom to enter into this Contract, as well as their capacity to perform the related legal acts, is in no way limited or excluded and, at the same time, declare that they have read the contents of this Contract and sign it as a token of their consent.
- 2.5 This Contract is made out of three (3) equal copies in Slovak and English; two (2) are for the Beneficiary and one (1) for the Donor.
- 2.6 **This Contract enters into force on the date of signing by both Contracting Parties and comes into force on the day following the date of its publication under Section 47a of the Act. 40/1964 Coll. Civil Code and Act No. 211/2000 Coll. on free access to information in the Central Register of Contracts – [www.crz.gov.sk](http://www.crz.gov.sk).**
- 2.7 The Donor agrees to the publication of the Contract under Clause 2.6 of this Contract.
