and by making them available to the operator who provided the grant for the activity:

VÚB Foundation, registered office Mlynské nivy 4121/1, 829 90 Bratislava, ID no: 30856043 (hereinafter referred to as "the Foundation"), for the purpose of presenting the results of the project and the Foundation's activities and including photographs in printed documents (e.g. the Annual Report), including photographs and audiovisual recordings in electronic documents, their dissemination through electronic media (e.g. websites managed by the Foundation and its founding company - VÚB, a.s., intranet, online magazines and online communication, social networks, etc.), making copies of photographs for the purpose of display.
The consent applies to all processing activities.

The consent applies to all processing activities carried out with the personal data for the same purpose.

The data subject consents to the processing of personal data for a period of five years from the date of the consent (30. 11. 2024). After the expiration of the aforementioned period, the Data Controller shall immediately carry out the destruction (deletion) of the personal data provided by the information systems of the Data Controller. That does not apply if the data subject has exercised his or her right to have the data erased under Article 17 of the GDPR. This period does not apply to audiovisual recordings and photographs already published. The consent may be withdrawn in writing at any time at the address of the Data Controller or by sending an e-mail to the e-mail address zodpovednaosobagdpr@snd.sk.

The data subject shall have the right, under the conditions laid down in the GDPR Regulation, to request access to personal data relating to the data subject from the Data Controller and the right to rectification or deletion or restriction of processing, or the right to object to processing, as well as the right to data portability. The rights of the Data Subject are regulated in Articles 15 to 23 of the GDPR in more detail and on the website of the Data Controller.

The Data Controller has a designated data protection officer whom the Data Subject may contact in relation to any questions concerning the processing of his/her personal data and to exercise his/her rights under the GDPR Regulation; contact details for the Controller's data protection officer: e-mail: zodpovednaosobagdpr@snd.sk or in writing to the Data Controller's address marked: "GDPR Responsible Person".

The controller shall only disclose the personal data of the data subject to the extent agreed and shall not transfer them to third countries. If the Data Subject presumes that the processing of the personal data concerning him or her is in breach of the GDPR, he or she may file a complaint with the Office for Personal Data Protection of the Slovak Republic, Hraničná 12, 820 07 Bratislava 27, tel. +421 /2/ 3231 3214, e-mail: statny.dozor@pdp.gov.sk or with another supervisory authority in accordance with Article 77 of the GDPR.

The data subject confirms that he or she has provided the personal data voluntarily, without coercion, that it is true and that he or she consents to its use for the specified purpose.
